On January 7, 2021, Special Agent (SA) Eric A. Kuusela with the Florida Department of Law Enforcement (FDLE), Fort Myers Regional Operations Center (FMROC), Sarasota Field Office (SFO), was instructed by Resident Agent in Charge (RAC) Greg Monk to review a citizen complaint documented in FDLE Case number FM-73-1000, Investigative Report (IR) number 85, regarding a possible Sunshine Law violation (Chapter 286 F.S.S.) in Manatee County, Florida.

SA Kuusela reviewed the information contained in FDLE Case Number FM-73-1000, IR 85, which contained the following information:

On December 11, 2020, FDLE SA David Sarney contacted Michael Barfield in reference to a possible Sunshine Law violation by several Manatee County Commissioners.

The substance of Barfield's complaint was that four (4) Manatee County Commissioners conspired to reverse a controversial land purchase and to have the county administrator fired. Barfield advised SA Sarney that he had thousands of pages of relevant documents to include telephone records, text messages, and transcripts.

On December 14, 2020, SA Sarney received an email from Barfield with a summary of alleged misconduct by commissioners.

SA Kuusela reviewed all of the relevant information provided by Barfield and found that Manatee County Commissioners James Satcher, George Kruse, Vanessa Baugh and Kevin Van Ostenbridge were the commissioners referenced by Barfield's complaint.

Barfield's complaint was originally sent to the Twelfth Judicial Circuit State Attorney's Office for review. State Attorney Ed Brodsky contacted the FDLE and made a request for the FDLE to conduct an inquiry into Barfield's Sunshine Law complaint.

Attached to this Investigative Report (IR) in the Related Items (RI) section of the case file are copies of Barfield's complaint under INV# 01.

On January 21, 2021 at approximately 10:00 AM, Special Agents (SA) Eric A. Kuusela and Brian Gregalot with the Florida Department of Law Enforcement (FDLE), Fort Myers Regional Operations Center (FMROC), Sarasota Field Office conducted an interview with Michael Barfield. The interview took place at the Law Office of Robert Watrous, located at 1800 2<sup>nd</sup> Street, Suite 780, Sarasota, Florida.

During the interview, Barfield said he was self-employed as a paralegal consultant for the last 30 years. On or about November 20, 2020, he read a news article in one of the Bradenton news outlets that reported about the termination of Manatee County Administrator Cheri Coryea. After reading the news article, Barfield reviewed the November 19, 2020, Manatee County Board of County Commission (BCC) meeting online through the Manatee County website.

After reviewing the BCC meeting, Barfield filed several public record requests for electronic mail, texts, telephone logs and social media accounts for four (4) Manatee County Commissioners. The four (4) commissioners Barfield requested from were Commissioner James Satcher, Commissioner Kevin Van Ostenbridge, Commissioner George Kruse and Commissioner Vanessa Baugh.

Barfield said that Commissioner Kruse provided him with telephone logs on or about December 7, 2020.

On or about December 7, 2020, Barfield filed a civil lawsuit against Commissioners Satcher, Van Ostenbridge and Baugh to compel them to comply with the public records request.

Barfield provided SA Kuusela with a copy of his complaint that was presented to SA David Sarney on a previous date.

The complaint alleged that Manatee County Commissioner James Satcher, Commissioner Kevin Van Ostenbridge, Commissioner George Kruse and Commissioner Vanessa Baugh violated the Florida Sunshine Law between November 3, 2020 (2020 Election night), through November 19, 2020 (Manatee BCC special meeting).

- October 28, 2020: Commissioner Baugh emailed commission candidate Van Ostenbridge a copy of County Administrator Coryea's employment contract.
- November 3, 2020: Candidate's Satcher, Kruse and Van Ostenbridge became Commissioners Elect.
- **November 10, 2020:** Commissioner Whitmore publicly said that people do not want County Administrator Coryea in the position she currently holds.

- **November 19, 2020:** Commissioner Van Ostenbridge met with County Administrator Coryea and asked for her resignation.

During the interview, Commissioner Whitmore stated that she has been a Manatee County Commissioner since 2006. Prior to becoming a County Commissioner, Commissioner Whitmore was a Holmes Beach City Commissioner and Holmes Beach Mayor.

Commissioner Whitmore serves as the at large commissioner in Manatee County.

SA Kuusela advised Commissioner Whitmore that the FDLE was conducting a preliminary criminal investigation regarding alleged sunshine law violation(s) by County Commissioners. Commissioner Whitmore advised she was familiar with the Florida Sunshine Law.

SA Kuusela asked Commissioner Whitmore about the events of a special meeting on November 19, 2020.

Commissioner Whitmore said that she and the other commissioners were sworn into office on November 17, 2020 at approximately 9:00 AM. Commissioner Whitmore advised that later in the evening, she was approached by Commissioner Kevin Van Ostenbridge who requested a special meeting regarding COVID-19 and possible presidential lockdowns. The meeting was scheduled for November 19, 2020.

Commissioner Whitmore said the special meeting that took place on November 19, 2020 went business as usual until Commissioner Vanessa Baugh presented a motion to have Resolution R-20-191 voted on.

Commissioner Whitmore advised that Commissioners Vanessa Baugh, George Kruse, James Satcher, and Kevin Van Ostenbridge all had a copy of the resolution proposed by Commissioner Baugh.

Commissioner Whitmore said that after the resolution vote, Commissioner Van Ostenbridge made a motion to terminate the County Administrator Cheri Coryea.

The vote was four (4) to three (3) to terminate Coryea as the Manatee County Administrator. Commissioner Whitmore said that she was surprised by Commissioner Van Ostenbridge's motion to terminate Administrator Coryea.

Commissioner Whitmore said that both the resolution by Commissioner Baugh and the motion by Commissioner Van Ostenbridge "looked like something fishy going on".

SA Kuusela asked Commissioner Whitmore if she had read any of the newspaper articles regarding the November county commission meeting. Commissioner Whitmore advised that she knew about the text message "she took the bait" purportedly made by Commissioner Van Ostenbridge. Commissioner Whitmore said the comment made by Commissioner Van Ostenbridge sounded preplanned and blatantly done.

Commissioner Whitmore said that on November 10, 2020, she attended a reception for departing commissioners where she overheard Commissioner Baugh talking to a Desoto County employee regarding a future county job opening in Manatee County government. Commissioner Whitmore said that she overheard Commissioner Baugh tell Tara Poulton (Desoto County employee) that there were a lot of changes coming and she should look around for positions opening. Commissioner Whitmore said Commissioner Servia was next to her and overheard Commissioner Baugh's comments to Poulton. Commissioner Servia rolled her eyes and laughed in disbelief of what she heard from Commissioner Baugh.

Commissioner Whitmore did not disclose any additional information regarding direct knowledge of violations of the sunshine law by other County Commissioners.

The interview concluded at approximately 1:55 PM. Also present during this interview was Assistant County Attorney (Manatee County) Pamela D'Agostino.

On January 25, 2021, at approximately 2:00 PM, Special Agents (SA) Eric A. Kuusela and Brian Gregalot with the Florida Department of Law Enforcement (FDLE), Fort Myers Regional Operations Center (FMROC), Sarasota Field Office conducted an interview with Manatee County Commissioner Misty Servia. The interview was conducted in Commissioner Servia's office at the County Administration Building, located at 1112 Manatee Avenue West, Suite 903, Bradenton, Florida 34205.

Commissioner Servia has been a Manatee County Commissioner since November of 2018. Servia served as the Vice Chairman of the Manatee County Board of County Commissioners (BCC) in 2019.

SA Kuusela informed Commissioner Servia that he was conducting a preliminary criminal investigation regarding alleged Florida Sunshine Law violations by a number of Manatee County Commissioners.

Commissioner Servia said she was familiar with the Florida Sunshine Law and has attended workshops provided by the county attorney regarding the Florida Sunshine Law.

Commissioner Servia said that there were a number of people both on the BCC and in the public sector that did not like the County Administrator, Cheri Coryea, as a professional.

SA Kuusela asked Commissioner Servia if she knew anything about the motion made by Commissioner Van Ostenbridge at the November 19, 2020, special meeting to terminate Administrator Coryea's employment contract. Commissioner Servia said that the special meeting was for concerns related to fears that President Biden was going to establish lockdowns because of COVID-19. Commissioner Servia had no prior knowledge of the motion by Commissioner Van Ostenbridge to terminate Administrator Coryea.

Commissioner Servia said that on November 10, 2020, during an event for outgoing commissioners, she overheard Commissioner Vanessa Baugh talking to Tara Poulton (Desoto County Economic Development & Community Services Division Director at DeSoto County Board of County Commissioners) near the cake table. Commissioner Servia said that Commissioner Baugh told Poulton that there was going to be an opening and a need for a new county administrator. Commissioner Baugh said Poulton should watch for the position.

Commissioner Servia said she had no other first-hand knowledge of any sunshine violations other than what she had read about in the newspapers.

Commissioner Servia said she had no knowledge of any BCC members in communication with each other regarding county business.

Commissioner Servia said that during the special meeting on November 19, 2020, she was very surprised of the timing and manner in which Commissioner Baugh motioned to pass Resolution R-20-191.

Commissioner Servia asked SA's Kuusela and Gregalot to leave her office so that she could confer with her attorney regarding additional information she had. SA's Kuusela and Gregalot left Commissioner Servia's office for approximately five (5) minutes.

SA's Kuusela and Gregalot returned to Commissioner Servia's office. Commissioner Servia said that during the afternoon of Thursday, January 21, 2021, she walked by Commissioner Van Ostenbridge's office and asked him how it was going. Commissioner Van Ostenbridge replied "it sucks". He then talked about legal fees and how Commissioner George Kruse would not talk to him because he and Commissioner Kruse had an agreement in which Commissioner Kruse changed his mind about the vote. Commissioner Servia said that after the conversation she left Commissioner Van Ostenbridge's office area.

The interview concluded at approximately 2:40 PM.

SA Kuusela asked if Commissioner Baugh recalled an event where she spoke to a Desoto County employee regarding employment in Manatee County during the evening of November 10, 2020. Commissioner Baugh said that she recalled the event and recalls talking with Tara Poulton who is the Economic Development & Community Services Division Director at the DeSoto County Board of County Commissioners. Commissioner Baugh said she knew Poulton lived and once worked in Manatee County and suggested she look for an opening on the Manatee County website if she ever wanted to return to Manatee County government. federal lockdowns. Commissioner Baugh knew of no other reason for the meeting.

SA Kuusela asked Commissioner Baugh about the resolution she presented during the special meeting that took place on November 19, 2020. Commissioner Baugh said that the Resolution, R-20-191, was introduced in order to have the ability to vote for a new chairman / chairwoman anytime. The former resolution only allowed for a vote for a new chairman / chairwoman during the 1<sup>st</sup> BCC meeting in the month of December. Resolution R-20-191 was an extension to Resolution R-20-065.

Commissioner Baugh said she did not have the original draft of Resolution R-20-191 in her possession.

Commissioner Kruse stated he was not aware of Commissioner Van Ostenbridge plan to request a special meeting on November 19, 2020, until the day he requested the meeting from Commissioner Carol Whitmore. Commissioner Kruse said that believed the meeting was in regard to COVID-19 and the potential overreach of the federal government regarding COVID-19.

Commissioner Kruse said he was present at the November 19, 2020 special meeting. Commissioner Kruse said he was not aware of Commissioner Vanessa Baugh's resolution

(Resolution-20-191) prior to the special meeting taking place and he did not have any prior discussions or communications with any of the BCC members regarding Resolution-20-191. He first became aware of the resolution sometime during the meeting when Commissioner Baugh handed each commissioner a copy of the resolution to review.

Commissioner Kruse said that he believed that the resolution would give the board the ability to immediately change policy rather than having to wait until another meeting to effect a change made by BCC members.

Commissioner Kruse stated that he did not privately discuss the removal of County Administrator Cheri Coryea with any other BCC member between the dates of November 3, 2020 and November 19, 2020.

Commissioner Kruse was questioned regarding phone records that showed several calls between himself and other BCC members between November 3, 2020 and November 19, 2020. Commissioner Kruse stated he did not discuss county business during any phone calls. Commissioner Kruse said that during those telephone calls with other BCC members he would ask about how he acquired items for his office, transition questions and other miscellaneous questions.

Commissioner Kruse stated he recalled sending a text message to Commissioner James Satcher on November 19, 2020, at 6:45 AM, that read, "ignore our call the other night. Stick to the original". Commissioner Kruse said that the text was in reference to what he and Commissioner Satcher were going to wear that day to the meeting. Commissioner Kruse said that Commissioner Kevin Van Ostenbridge was planning on wearing a tuxedo. The "original plan" was to wear jeans rather than a suit.

Commissioner Kruse had no additional information to provide to agents. Also present during the interview was Commissioner Kruse's attorney, Kristy Guy Zinna.

The interview concluded at approximately 2:15 PM.

On February 5, 2021, at approximately 1:30 PM, Special Agents (SAs) Eric Kuusela and Brian Gregalot with the Florida Department of Law Enforcement, Fort Myers Regional Operations Center (FMROC), Sarasota Field Office (SFO) conducted an interview with Manatee County Administrator Cheri Coryea. Administrator Coryea became the County Administrator in 2019. Prior to her current appointment, Administrator Coryea has served Manatee County as the Deputy Administrator and department director of several departments within county government.

Administrator Coryea said she did not have any first-hand knowledge of any Manatee County Board of County Commissioners (BCC) members violating the sunshine law. She speculated that some BCC members began to plan for her termination during a gathering prompted by Commissioner Vanessa Baugh on November 17, 2020 at the Riviera Dunes Dockside in Palmetto. Administrator Coryea said that several staff members told her that after the BCC meeting at the Bradenton Area Convention Center, several BCC members went over to the Riviera Dunes Dockside to have drinks. Administrator Coryea said she had no evidence of any illegal conduct by BCC members during the gathering.

Administrator Coryea stated that during the meeting with Commissioner Van Ostenbridge on November 19, 2020, he asked for her resignation. During the meeting, Administrator Coryea said she took detailed notes of the conversation. Administrator Coryea said that Commissioner Van Ostenbridge told her he had the votes to reconfigure the land deal (Lena Road land deal) that was passed on October 13, 2020 prior to the new commissioner's being sworn in on November 17, 2020.

Administrator Coryea provided SA Kuusela with copies of text messages obtained through a news media outlet. The copies are attached to this Investigative Report (IR) in the Related Items (RI) section under INV# 3.

Commissioner Satcher stated that he was not aware of Commissioner Van Ostenbridge's request to have a special meeting on November 19, 2020 prior to the day Commissioner Van Ostenbridge requested the meeting from Commissioner Carol Whitmore on November 17, 2020. any discussions or communications to include private meetings, call, text or emails with any BCC member regarding Commissioner Baugh proposed resolution.

Commissioner Satcher stated he did not discuss Commissioner Van Ostenbridge's motion to terminate County Administrator Cheri Coryea with any other BCC member between November 3, 2020 and November 19, 2020.

Commissioner Satcher said that he was unaware of Commissioner Van Ostenbridge's meeting with County Administrator Coryea to ask for her resignation.

Commissioner Satcher was questioned regarding phone records that showed several calls between himself and other BCC members between November 3, 2020 and November 19, 2020. Commissioner Satcher stated he did not discuss county business during any phone calls.

Commissioner Satcher stated he recalled receiving a text message from Commissioner George Kruse on November 19, 2020 at 6:45 AM that read, "Ignore our call the other night. Stick to the original". Commissioner Satcher stated he did not know what the text message was about and was asleep when the text message was sent to him. He said that after he woke up he saw the text he no idea what Commissioner Kruse was talking about.

Commissioner Satcher had no additional information to provide to agents.

Also present during the interview was Commissioner Satcher's attorney, Robert Robinson.

The interview concluded at approximately 4:50 PM.

On February 8, 2021, at approximately 1:30 PM, Special Agents (SAs) Eric Kuusela and Brian Gregalot with the Florida Department of Law Enforcement (FDLE), Fort Myers Regional Operations Center (FMROC), Sarasota Field Office (SFO) conducted a telephone interview with DeSoto County Economic Development & Tourism Director Tara Poulton. Poulton was referenced in several Investigative Reports (IR) in the case file regarding a conversation she had with Manatee County Commissioner Vanessa Baugh on November 10, 2020 during a social event in Manatee County, Florida.

Poulton currently serves as the DeSoto County Economic Development & Tourism Director and has had the position since 2017. Prior to working in DeSoto County government, Poulton worked for several years for the Southwest Florida Water Management District, responsible for Manatee, Sarasota, DeSoto and Charlotte Counties.

Poulton stated she attended an event on November 10, 2020, from approximately 3:00 PM to 5:00 PM, at the Bradenton Area Convention Center celebrating Priscilla Trace and Betsy Benac's service to Manatee County.

During the event, Poulton recalled talking with Manatee County Commissioner Baugh near the cake table. Poulton said that Commissioner Baugh asked her how things were going in DeSoto County. Commissioner Baugh then talked about her potentially returning to work in Manatee County and that a couple of positions should be opening soon. Poulton said Commissioner Baugh did not talk about any specific position that would be coming available within Manatee County government.

Poulton recalled during her conversation with Commissioner Baugh she noticed Commissioner Misty Servia standing nearby with a weird look on her face.

Poulton ended the conversation with Commissioner Baugh and did not think any more about the conversation until recently when a reporter contacted her and asked about the conversation she had with Commissioner Baugh.

Poulton said she did not know what positions Commissioner Baugh was referring to during the conversation and she has not spoken to Commissioner Baugh since the event on November 10, 2020.

On March 12, 2021, Special Agent (SA) Eric Kuusela with the Florida Department of Law Enforcement (FDLE), Fort Myers Regional Operations Center (FMROC), Sarasota Field Office (SFO) conducted a review of the case file.

During the review of the case file, the following information was summated:

On or about January 21, 2021, SA Kuusela obtained a complaint from Michael Barfield alleging that Manatee County Board of County Commissioners (BCC) James Satcher, Kevin Van Ostenbridge, George Kruse and Vanessa Baugh violated the Florida Sunshine Law between November 3, 2020 through November 19, 2020. SA Kuusela reviewed documents provided by Barfield which included telephone records and text messages purportedly from a telephones utilized by Manatee County Commissioners.

During the course of this inquiry, SA Kuusela conducted interviews with BCC members and witnesses between January 25, 2021 through February 11, 2021.

SA Kuusela requested and was granted subpoenas issued by the Twelfth Judicial Circuit State Attorney's Office for cellular telephone records for BCC members Satcher, Van Ostenbridge, Kruse and Baugh. After learning that the cellular telephones used by the County Commissioners were personally owned devices and not Manatee County government issued telephones, SA Kuusela contacted the Twelfth Judicial Circuit State Attorney's Office and a mutual decision was made to rescind the subpoenas issued to BCC members on February 18, 2021.

After the review of all of the information obtained during this preliminary inquiry, it has been determined that there is insufficient evidence to demonstrate that a criminal violation of the Florida Sunshine Law or any other Florida statute occurred. Therefore, this case will be closed.
