#### AFFIDAVIT IN SUPPORT OF ARREST WARRANT

BEFORE ME, A NOTARY PUBLIC OF THE STATE OF FLORIDA, personally appeared Detective Carmine Luper, of the Manatee County Sheriff's Office, who being duly sworn, says that on the date of February 4th 2021, in the County aforesaid, one Owen Hagan did unlawfully commit 26 counts of Possession of Certain Images of Child Pornography.

To Wit

On 02-04-2021 a report from the National Center for Missing and Exploited Children known as NCMEC was received. NCMEC received a cyber-tip report from Dropbox, Inc., in reference to the distribution of files containing possible Child Pornography. According to the number report 85460761. an individual which has bat4f3vmx9@privaterelay.appleid.com, and a screen/user name Owen Hagan, uploaded 4 video files containing child pornography between 12-20-2020 at 16:00:00 UTC and 02-04-2021, at 08:34:48 UTC. Also associated with the account is the IP address of 2600:1700:b160:5430:3814:cbae:3268:9211 and 174.66.202.161.

Your affiant viewed the 4 video files. These video files are described as follows:

  Filename: "Video Dec 31, 7 00 00 PM (5).mp4" with a MD5 number of "877720de504c907c1bb29abdacbbf994". This video is 03:43 minutes in length. This video depicts a juvenile female, that is approximately 9 to 12 years of age and completely naked. The juvenile female is sitting a be a juvenile made. be a juvenile male, who is also naked, between her legs. The juvenile male has his penis exposed to the camera and he inserts his penis in to the juvenile female's vagina and proceeds to have sex with her. This continues for the duration of the

This video depicts a juvenile female, approximately 9 to 12 years of age that is naked from her waist down and lying on her back on a bed. The juvenile female has her vagina and anus exposed to the camera. The juvenile begins to masturbate using her fingers and then an adult male enters the video. The juvenile female begins to

- perform oral sex on the adult male. The adult male then inserts his penis in to the vagina of the female and begins to have sex with her.
- Filename: "Video Dec 31, 4 00 00 PM.mp4" with a MD5 number of "b84ba52de91fc272a255073e470b3540". This video is 04:14 minutes in length. This video depicts a juvenile female, approximately 11 to 13 years of age, that is fully clothed and a juvenile male that is approximately 13 to 16 years of age and only wearing shorts. As the video begins the juvenile female takes off the shorts of the juvenile male, and then his underpants exposing his penis to the camera. The juvenile male then takes off the shorts of the female, which exposes her vagina to the camera. The juvenile male then turns the juvenile female around and she gets on her knees. The juvenile male gets behind her and places his penis inside her vagina. The juvenile male proceeds to have sex with the juvenile female. At the 01:30 minute mark the male juvenile lays down on the bed and the juvenile female gets on top of him. The juvenile female inserts the male's penis inside of her and they continue to have sex in this fashion for the remainder of the video.
- Filename: "Video Dec 31, 7 00 00 PM.mp4" with a MD5 number of "85548eebb60155a0d13ccced9996f318". This video is 01:50 minutes in length. This video depicts a juvenile female, approximately 9 to 12 years of age, that is completely naked and facing the camera. There is an adult male that is behind her and sitting down. The adult male has his hands around the juvenile female's waist and she sits down on the adult male's lap. The adult male has an erect penis and he places the juvenile's legs on either side of his, exposing her vagina to the camera. The adult male then inserts his penis in to the juvenile female's vagina and begins to have sex with her. This continues for the duration of the video.

A second Cyber-Tip was received from NCMEC and this Cyber-tip report number is **86062972** which was received on 02-15-2021. This Cyber-tip was sent to NCMEC from **Dropbox Inc**. This Cyber-Tip advised that the Dropbox user of **Owen Hagan** with the e-mail address of **copenhagan37@gmail.com** and the IP address of **2600:1700:b160:5430:1b3:c419:d900:2a41** uploaded **11** video files. I viewed these files and **10** of these files depicted Child Pornography.

Your affiant viewed the 11 video files, 2 of these video files are described as follows:

- Filename: "2019-04-17 21.23.33.mov" with a MD5 number of "1d1f5f9d7e0736687f3018094bd31fe7". This video is 54 seconds in length. This video depicts a juvenile female, approximately 9 to 12 years of age, that is completely naked, with the exception of wearing socks. The juvenile female is sitting down and has her vagina exposed to the camera. The juvenile female turns away from the camera and gets on her hands and knees, sticking her buttocks in the air. This exposes the juvenile's anus and vagina to the camera. The juvenile then proceeds to masturbate and rub herself until the 50 second mark, where she gets up and walks away from the camera.
- Filename: "likemyoung.mp4" with a MD5 number of "71e3ad1d7e73b774dde0166332f436af". This video is 01:51 minutes in length. This

video depicts a juvenile female that is approximately 10 to 13 years of age and she begins the video fully clothed. The juvenile female is standing up and she begins to take off her clothes. The juvenile takes off her shirt first and begins to rub her breasts, then proceeds to take off her shorts, followed by her underwear. The juvenile has her vagina exposed to the camera at the 01:20 minute mark and she begins to rub herself. The video ends with the juvenile being completely naked, facing the camera, and rubbing herself.

Your affiant was able to determine that the files associated as referenced above were live pictures of real human beings and not digitally created images of humans. Your affiant was able to determine this based on training and experience that the technology does not exist to create digital images or videos of truly life-like humans. Your affiant has viewed the most advanced forms of digital human beings and knows that the images described above are vastly different in quality and are clearly not animated or manufactured.

Through investigative means it was learned that the IP address of **2600:1700:b160:5430:3814:cbae:3268:9211** came back to AT&T. A subpoena was sent to that company for subscriber information. The response from that company had the following information:

The IP address of 174.66.202.161 comes back to Cox Communications. A subpoena was sent to Cox Communications; however, a response has not yet been received as of this writing. A subpoena has also been generated for Google, for the Gmail account of copenhagan37@gmail.com. I received a response from Google LLC, after the interview with Owen was conducted, with the following information:

CLEAR is an online investigation software that searches thousands of data sets based off of the input provided by the user, to locate information.

A search using CLEAR shows that the phone number of (440)-665-7711 once belonged to an Owen P. Hagan with a DOB of 03-11-94 and it was on a Utility Service, from when he lived in Ohio.

On 03-17-2021 I was advised that Investigator M. Arena with the Ohio Internet Crimes Against Children Task Force was investigating another NCMEC Cyber-Tip 83004091 involving the same subject. I was additionally advised that a search warrant was completed on the residence

located at 2501 Hampton Rd, Rocky River OH 44116. I was sent a copy of their search warrant, which included the IP address of **174.66.202.161** which was associated to their Cyber-Tip as well. They had received a return from Cox Media which showed account information of:

They also obtained subscriber information for the Kik user account associated with their Cyber-Tip which had an e-mail address of <a href="mailto:ian.kilbane37@gmail.com">ian.kilbane37@gmail.com</a> and a screen/username of "copen371" along with the ESP USER ID of "copen371\_4dr". They obtained subscriber data which shows:

After Investigator M. Arena completed a public record query they confirmed that an Owen Hagan with the date of birth of 03-11-94 had a recent address of 2501 Hampton Rd, Rocky River OH 44116.

They executed a search warrant on the residence and through their investigation they learned that the Owen Hagan subject had recently moved to Florida to live with his mother, Melinda Hagan at an address within Manatee County Jurisdiction.

On 03-17-2021 I responded to Palm Bay Mobile Home Park at 751 10<sup>th</sup> St E, along with Detective S. Luke to try and locate Owen Hagan. I contacted Melinda Hagan, who confirmed that her son Owen was living with her, and he should be inside. Melinda allowed law enforcement inside of her residence, and she opened the door to Owen's room, where he was on his bed. Contact was made with Owen and an interview was completed.

During the consensual interview, Owen advised that he only had one phone and he provided the password to the phone when I asked him for it. Owen initially advised that Law Enforcement could look at his phone, but then changed his mind stating that he preferred that law enforcement did not go through and look in his phone. Because of this, the phone was placed into "airplane mode" and then left alone. Owen was asked if we could search his room for any additional electronics and he stated that we could. Owen's room was searched and no additional electronics were located. While the search was being conducted I continued my interview with Owen. Owen confirmed that his e-mail address was "copenhagan37@gmail.com" and stated that he did not have any other e-mail addresses. Owen advised that his phone number is 440-463-2174 and he isn't sure what type of iPhone his phone is. Owen also advised that he obtained his current phone, from a family member, back sometime around "April-August" of last year and the phone

was not factory reset prior to him receiving the phone. Based on Owen's statements, the white iPhone with a black case (referred to as item CL1) was confiscated as, according to Owen, that is the only electronic device that connects to the internet, that he uses or has access to and there were no other electronic devices located within Owen's room.

A forensic analysis of Owen's phone, the iPhone 6s (referred to as item CL1) was completed by Det. S. Luke and provided to your affiant. I viewed the Cellebrite Reader report and I observed the following information to be on the phone:

Within the Web History section of the iPhone it shows that the user of this phone went to "Dropbox.com" 5 times on 11-30-2020 between 03:52:25 (UTC-5) and 07:32:01 (UTC-5). The user went to "Dropbox.com" 4 times on 02-14-2021 at 04:24:45 am (UTC-5). Additionally, the user of this phone went to "Dropbox.com" 13 times between 02-19-2021 at 05:46:36 am (UTC-5) and 02-20-2021 at 03:46:00 am (UTC-5).

Within the E-mail section of the report, it shows that the e-mail of <a href="mailto:owen.hagan37@gmail.com">owen.hagan37@gmail.com</a> received an e-mail from <a href="mailto:no-reply@dropbox.com">no-reply@dropbox.com</a> advising that there was a new sign in to the account on 02-14-2021 at 04:24 am (EST). This matches the log in that was done by this phone on that date. Additionally the e-mail of <a href="mailto:copenhagan37@gmail.com">copenhagan37@gmail.com</a> received an e-mail from <a href="mailto:no-reply@dropbox.com">no-reply@dropbox.com</a> advising that there was a new sign in to the account on 02-14-2021 at 04:25 am (EST). This also matches the timeframe for when the user of the iPhone was on the "dropbox.com" website

Within the User Accounts section of the report, it shows Owen Hagan as an account. Additionally, it shows a user account for Kik with the name of "Owen K" and username of "Owenh3711". There is a Facebook ID associated to the phone, showing the user of Owen Hagan and two different usernames, one being "owen.hagan.12" and the other "owenhagan". There is a Tinder account showing a user of "Owen". Additionally, the following e-mails are showing associated to this phone in the accounts section:

The <u>owen.hagan37@gmail.com</u> account is showing associated to the user's iCloud, Find My Friends, CloudKit, Game Center, Messages and Gmail.

Within the Notes section of the report, it shows 3 different notes. Each of the notes has one or more links to "Mega". Additionally, the notes each have a different "Creation Time" and "Modification Time" ranging from 01-22-2021 at 2:34:34 AM (UTC-5) to 02-02-2021 at 4:42:37 AM(UTC-5).

Within the Searched Items section of the report, it shows that the user of the phone searched for "Illegal Telegram channels", "telegram rape group", "delete snapchat", "kik daughter group" and "kik share daughter group". These searches ranged from the dates of 11-23-2020 at 03:35:38 PM(UTC-5) to 2-19-2021 at 5:43:39 AM(UTC-5). Additionally, there was a Facebook search which resulted in a "Private Group" with the name of "Teen adds <3".

Within the Web History section of the report, it shows that the user of this phone went to several Russian websites, one of which is a known child pornography website, and it was gone to at least 89 times between 12-1-2021 and 2-25-2021. Additionally, between the timeframe of 11-22-2021 and 03-16-2021 the user of the phone went to websites stating "teen", "1..4", 1)4", "Dropbox", "Mega", "dad daughter Kik Sexting", "young & sexy 16yo / 17yo", "15y", "American teen", "My 16", "Beautiful young teen", "share daughter group", "a friends cute 10 ear od daughter", "cute teen girls love it rough", "telegram rape group", "Teen bbc", "child porn" and "new child sex" on multiple occasions and throughout the timeframe shown.

Within the Web Bookmarks section of the report, it shows that there are 55 bookmarks directed towards a ".RU" website that is known to host Child Pornography.

Within the Chats section of the report there are multiple different chats where the user of the phone talks about wanting to "rape" girls. Additionally, there is a chat that started on 03-17-2021 at 12:53:17 PM(UTC-4) using KiK Messenger where the user of "Owen K" is speaking with a subject named "Emila" who states she is a "14female us". The conversation continues both subjects exchange images of their face. The image shared by "Owen K" is in fact Owen Hagan. After the images were shared "Owen K" replies "You wanna be raped". "Emila" replies "Mwyabe". The last conversation in this chat is from "Owen K" stating "How" on 03-17-2021 at 1:01:51 PM (UTC-4). There are 4 additional chats in which the user "Owen K" messages different people talking about wanting to obtain images of juveniles, or about how he wants to have sex with and/or rape juveniles. (It should be noted that all these chats occurred on the same day that law enforcement contacted Owen Hagan). Also, these chats go back as far as 2017 showing Owen in some sort of possession of the phone, where messages state things like "Yo fin it's Owen you trying to toss some bags" or from 2019 where the user sends "Moises its owen" and the chat continues. In 2020 a message from December states "Hey dickhead it's Owen". On 3-11-2021 there is a chat string using Facebook Messenger that shows the user as "Owen Hagan". Additionally, the subject responding in that chat specifically states "owen!!" in one of their chats.

Within the Images section of the report, there are multiple images depicting Owen Hagan, some of which appear to be "Selfie" images. These images are throughout the phone and are between the dates of 7-11-2021 at 3:05:10 PM(UTC-4) and 03-15-2021 6:00:03 AM(UTC-4). There were also multiple images that would be considered "Child Erotica" or I was unable to determine and approximate age of the subjects in the image. Within this section there were 11 individual images that would constitute a violation of F.S.S. 827.071(5) (A).

Within the Videos section of the report, there is a video showing a driver license belonging to "Owen Hagan" and another showing a birth certificate for an "Owen Hagan". There are 22 videos depicting sexual conduct of subjects where I could not determine an estimated age, or they were duplicate videos. Additionally, there are 15 videos that would constitute a violation of F.S.S. 827.071(5) (A).

Contact was made with the prosecutor working this case in Ohio. After speaking with prosecutor, Fallon Radigan, it was determined that they would pursue any charges that might be obtained through "DropBox" as it was logged into in Ohio and that is where their Cyber-Tip information was obtained. Any of the images and/or videos on the phone would be within the jurisdictional boundaries of Manatee County Sheriff's Office as Owen Hagan was within Manatee County and in possession of the phone, where the following videos and images were located, when contact was made with him.

On this phone, marked as CL1, I located 26 images and/or videos that depicted Child Pornography. Of these images and/or videos at least 26 of them were unique and constitute a violation of F.S.S. 827.071(5) (A). Additionally, there was sufficient information on the phone that documented that Owen Hagan had been in use of this phone before, during, and after any type of Child Pornography was downloaded on to the phone and that the user of this phone actively sought out Child Pornography. Owen Hagan was also in possession of and confirmed this was his phone, when I contacted him. Due to this I believe there is probably cause to charge Owen Hagan with the following images and/or videos.

- (a) The offender possesses 10 or more images and any form of child pornography regardless of content; and
- (b) The content of at least one image contains one or more of the following:
- 1. A child who is younger than the age of 5
- 2. Sadomasochistic abuse involving a child
- 3. Sexual Battery involving a child
- 4. Sexual bestiality involving a child
- 5. Any movie involving a child, regardless of length and regardless of whether the movie contains sound.
